

# Sheriff K-9 trapshoot set for this Saturday at Berlin Conservation Club

With K-9 Kai and K-9 Ash already on the roster, the Green Lake County Sheriff is looking to add a third K-9 in the near future by raising funds at a 50-bird trapshoot on Saturday, September 20.

Organized by Green Lake County Crime Stoppers, the fundraising event will be held from 8:30 a.m.–5 p.m. at the Berlin Conservation Club, W898 White Ridge Rd., Berlin.

Registration for the 50-bird trapshoot will take place from 8:30 a.m.–2:30 p.m., and costs just \$40 per trapshooter, which includes Lewis Class, Lucky Number and High Gun.

For non trapshooters wishing to show their support of the Sheriff’s K-9 program, there are also raffles for

two guns, for just \$20 a ticket or three tickets for \$50, as well as a basket raffle for dozens of donated baskets. Tickets for the basket raffle are \$5 each, three for \$10 or 10 tickets for \$20.

In addition to the trapshooting competition and raffles, the Green Lake County Sheriff’s Office will be hosting drone demonstrations at 11 a.m. and 1 p.m., in addition to a K-9 demonstration at noon.

Special Sheriff’s Office equipment will also be on display and food and beverages will be available for sale throughout the day.

All are invited to the Berlin Conservation Club on Saturday, September 20, to show their support to the Green Lake County Sheriff’s Office and the K-9 program.
